Partners in Ministry Projects

The John 3:16 Innovation for Ministry Mini-Grant Program for Partners in Ministry provides a team of at least four church members <u>one-time mini-grants of up to \$1,500 for the purpose of partnering with existing church-based or Christian ministries, or not-for-profit organizations, in Winston-Salem whose mission is consistent with the priorities of First Baptist on Fifth. Mini-grants should support ministry that aligns directly with one of First Baptist on Fifth's four mission and ministry priorities: (1) cultivating the well-being of children; (2) mitigating poverty in our community; (3) becoming a teaching and learning church; and (4) growing in number and faithfulness. They should also lead to the measurable expansion of our congregation's hands-on participation in the ministry or program that is being funded.</u>

Because First Baptist on Fifth is a congregation that upholds the dignity and value of all people, we require all Partners in Ministry Grant proposals to include the partner organization's non-discrimination clause.

Partners in Ministry Mini-Grants are typically non-renewable. In special circumstances and pending a thorough assessment of the initial grant, successfully completed grants may possibly be eligible to apply for one renewal during the entire grant period, but this should be considered an exception rather than the rule. All proposals should be written with the expectation that the award is non-renewable.
